



Tata-Cornell Institute for Agriculture and Nutrition 2022 Summer Internship Program

The Tata-Cornell Institute for Agriculture and Nutrition (TCI) is pleased to offer funding for a 6-8 week student internship program in India for first-year graduate students during the summer of 2022. This is a competitive, merit-based internship that requires candidates to engage full-time with development-related research projects in India.* Interns will contribute to the ongoing research projects developed by TCI in conjunction with several of our partner collaborators. This internship program will be of interest to students in units like government, economics, agriculture, international relations, development studies, health, nutrition, human ecology, anthropology, sociology, gender studies or related fields.

The Objective

- To provide students with a fieldwork based learning experience on topics relating to agriculture, food and nutrition
- Enhance the participants understanding of food policy and challenges within food systems in the context of India
- Exposure to data collection and management, and development of analytical skills
- Identify topics and collect data towards a potential master's thesis or independent study

*Due to the uncertainty posed by the COVID-19 pandemic, offering an internship experience in India may not be possible. In that event, TCI will offer internships remotely or based in Ithaca, New York.

Timeline

Application Deadline and selection: Students must submit a completed application, resume, and the signed release form **by Friday, January 28, 2022** to Dan Verderosa at dv242@cornell.edu. Shortlisted candidates will be interviewed at the end of February and awards will be announced in early March.

Pre-departure workshop and preparation: Selected students will be required to attend a mandatory pre-departure workshop conducted by TCI to be held in the late spring of 2022. Students will be required to work closely with TCI staff and the partner collaborator in order to coordinate all internship program details and logistical arrangements for their stay.



Internship: 6-8 week internship with TCI or partner organization

Seminar: Students are required to participate in a reflective seminar to process lessons learned and further develop research conducted in the field. As deliverables, students will complete both a written report and an oral report at a TCI-arranged seminar by the end of the fall semester.

Program and Placement

Selected interns will contribute to the ongoing research projects developed by TCI. Interns may also be placed with one of our partner collaborators.

Every effort will be made to ensure that the selected student is assigned to his/her preferred area of interest and skillset; however, the TCI or partner collaborator may need to assign the student to a project that best meets the partner collaborator's needs.

Students will work under an assigned mentor at the TCI office/partner organization and will be evaluated by these mentors at the conclusion of the internship period. In addition, students will need to submit a bi-weekly blog during their internship period.

Internship Awards will cover airfare, visa fees, in-country travel and allowance for housing and living expenses.* TCI staff will guide students through the visa application process, but students are responsible for obtaining their travel documents (passport, visa and vaccination card) in a timely manner.

*In the event that a remote or Ithaca-based internship is offered, interns will receive an hourly wage in lieu of a stipend.
